## **Company Overview**

ASQ Allstone Quarries is dedicated to supplying its customers with a diverse range of quality products, combined with outstanding service. Our quarry produces and supplies quality crushed rock and aggregate materials to Bendigo and the surrounding district. We maintain large stockpiles of our products and our sales team provides a fast and safe turnaround. We also offer a mobile crushing operation in addition to the fixed plant, which is located at Newbridge.

## **Primary Purpose of the Position**

The Quarry Foreman is responsible for ensuring safe and efficient day-to-day quarry operations including supervising site workers, overseeing equipment, monitoring site systems, and coordinating production and resources to meet targets. The Quarry Foreman is second-in-charge to the Quarry Manager.

## **Key Responsibilities**

- 1. Compliance with the ASQ Document Management System [Operational and Workplace Health, Safety and Environment (WHSE)]:
  - Adhering to and ensuring that workers comply with all ASQ policies and procedures and government legislations.
  - Ensure all operations comply with the company's environmental objectives.
  - Assist with regular site inspections, audits, and risk assessments to ensure compliance with WHSE regulations.

### 2. Accountabilities:

**Daily Operations:** 

- Asset management in relation to operations, maintenance and record-keeping in internal systems.
- Ensure a high level of customer service and that the correct and appropriate advice is given.
- Ensure the site runs according to standard operating procedures.
- Assist in the management of pit operations including stripping, drill, blast, load and haul and rehabilitation.
- Assist in the management of processing plant including crushing, screening, stock piling and sales loading.
- Assist with and coordinate quarry maintenance.
- Assist in the administration of audits as required by regulatory authorities.
- Responsible for general site maintenance and presentation.
- Achieve production targets set by the Quarry Manager.
- Ensure product quality to required specifications in accordance with the Quality Management Plan.

### Management of site workers:

• Coordinate with the Quarry Manager on rostering, approving timesheets, overtime and leave request of workers where required.



- Recruiting and inducting new workers in consultation with the Quarry Manager.
- Responsible for inducting contractors as required.
- Managing daily tasks of workers.
- Managing performance and conduct issues in consultation with the Quarry Manager.
- Completing performance reviews and providing regular feedback to foster a high-performance culture.
- Training, developing and mentoring all workers as required.
- Assist in ordering uniforms and PPE gear as required.
- Relieving workers where required.

#### Others:

- Operate the weighbridge and perform associated tasks when required.
- Assist with concrete batching as required.
- Assist in the Quarry Manager's responsibilities during their absence to ensure the continuation of operations.
- Attend management meetings as required.
- Submitting monthly reports to the Quarry Manager.

- Competent in at least five Quarry core competencies.
- Work outcomes will be monitored.
- Work under the general direction and close supervision of the Quarry Manager.
- Supervise other workers.
- Have the freedom to act within established guidelines.

- 3. Experience in operating a fixed or mobile crushing plant.
- 4. Experience with point-of-sale systems (desirable).

- 7. Level 2 in First Aid.
- 8. Minimum competency in loader, excavator, skid steer and dump truck (desirable).
