## Primary Purpose of the Position

The Truck Driver Multi-Combination (MC) is responsible for the safe and efficient unloading and delivery of product to customers, performing float work as well as maintaining the presentation of the truck and ancillary equipment.

## Key Responsibilities

### 1. Compliance with the ASQ Document Management System [Operational and Workplace Health, Safety and Environment (WHSE)]:

- Adhering to all ASQ policies and procedures.
- Adhering to OHS legislation and regulations.
- Ensure all operations comply with the company's environmental objectives.
- Ensure transport fleet operated within governing legislation and requirements, including but not limited to compliance with:
  - National Heavy Vehicle Regulator (NHVR) requirements and all state and federal road rules
  - National Heavy Vehicle Accreditation (NHVAS) requirements
  - Codes of Practice and Australian Standards
  - Mass Management requirements
  - Performance Based Standards (PBS)
  - Chain of Responsibility (CoR) legislation
  - Fatigue Management
- Attend Transport Meetings
  - Toolbox meetings
  - Pre-start meetings

### 2. Accountabilities

Delivery of product and exceptional customer service:

- Follow fatigue management plan – document and log work/rest periods and distance spent driving.
- Ensure all communication from Weighbridge Operator, Transport Manager and Operations Manager is understood and followed.

- Follow Chain of Responsibility including mass management (vehicle and axle weights), fatigue management, permits, journey planning and B Double Road network.
- Make sure loads are correctly placed and secured to avoid damage to both truck, goods and property in accordance with Heavy Vehicle National Law and Regulations
- Timely delivery of product as scheduled and in line with Heavy Vehicle National Law and Regulations
- Effective use of vehicle to maximise vehicle utilisation.
- Collection of money from customers on delivery and returned to office if required.
- Ensure all required documentation is complete and forwarded at appropriate times, for example, daily running sheets.

Maintain presentation of the truck and ancillary equipment:

- Daily prestart, greasing and basic maintenance of truck and ancillary equipment
- Report all defects, accidents and violations to Transport Manager and Maintenance Manager in a timely manner.
- Ensure trucks are safely and securely stored.
- Ensure trucks and equipment are kept cleaned.
- Assisting with yard duties and truck maintenance jobs

### **3. Direction, management and autonomy**

- Follow instructions from Transport Manager and Weighbridge Operator regarding schedules, routes and operational instructions while complying with road laws, fatigue management and company policies.
- Seek operational support when required to receive clear job details, training or guidance to meet performance and safety standards.
- Work outcomes are monitored.
- All practices and expectations are in accordance with the standards set forth in the Road Transport Distribution Award.
- Regularly communicate with the weighbridge office regarding delays, route changes, or any issues encountered during transit.

## **Key Selection Criteria**

1. Experience driving truck and dog combinations and/or semi tipper and also experience in tipping and spreading.
2. Experience with float work required.
3. Experience with using GPS, UHF and smartphone technology.
4. Extensive knowledge of the National Heavy National Law and regulations and Chain of Responsibility legislation
5. Sound literacy, numeracy and IT skills.
6. Ability to work weekends and public holidays as required.

8. Construction Induction (mandatory)
